A MESSAGE FROM SHERIFF BARNES

Greetings from the Office of the Sheriff. My name is Brandon Barnes and I am the 24th Sheriff elected to Sutter County. I am a long time Sutter County resident and my wife, Jennifer, and I make our home in Live Oak. Together, we share four children, ages 16 to 25 years old. After serving 23 years at a neighboring agency, I decided to run for this office to better serve my community through strict enforcement practices and a community mindset for improving our quality of life.

Upon taking office, I felt strongly the Office of the Sheriff needed to produce an annual report that captures our accomplishments throughout the 2018 calendar year. This report is designed to inform the Board of Supervisors, as well as, the public about what goes on in “their” Sheriff’s Office. I am honored to have my name attached to this report as I took office on December 29th of 2018. However, I would be remised if I did not note many of the accomplishments listed in this report are attributed to Sheriff J. Paul Parker, Undersheriff Jeff Pierce, and their staff. Both Sheriff Parker and Undersheriff Pierce served this community, more than 30 years, and they left a solid foundation for my administration to build upon.



In this report, you will get an overview of our three main divisions within the department; Operations, Corrections, and Support Services. Each division is distinct and provides a wide variety of services, but it is the sum of these divisions that makes us a truly professional organization. Our success is due, in large part, to the men and women who serve this community as members of the Sheriff’s Office.

You will receive some insight into the Sheriff’s Budget, which is comprised of 9 different budget components. The Sheriff’s Office also relies on grant funding to help offset costs and ensure all local tax dollars are being maximized within the department.

The Sheriff’s Office is required to report Uniform Crime Reporting Statistics, more commonly referred to as URC Stats, to the Federal Government. In 1930, the FBI was tasked with compiling crime data to show crime trends throughout the country. Agencies can use this information to compare trends occurring in their jurisdiction to national averages. The UCR Stats for Sutter County are included in this annual report.

In 2018, there were several retirements, promotions and accommodations throughout the organization, including the retirements of Sheriff Parker and Undersheriff Pierce. This report will memorialize that information and provide some insight as to how the organization is structured.

I sincerely hope you find this report beneficial. I look forward to producing a similar report in the coming years, specifically as it relates to sharing the excellent work we will accomplish during my first year in office. We work to serve this community and to that end, it is our obligation to keep the community properly informed.

K-9 Bandit



Deputy John Lopez, picked up his new canine partner, K-9 Bandit, on May 11th, 2017, from the San Francisco Airport. Bandit and Deputy Lopez hit it off from the moment they met at the airport and he knew it was going to be the beginning of a great partnership. Bandit and Deputy Lopez began the DTAC K-9 course on June 12th, 2017. On June 27th, 2017, Bandit POST certified for patrol on his first try. Although, he passed his POST certification early, Bandit and Deputy Lopez had to complete the course before he was given the okay to deploy on the streets of Sutter County. By mid-July 2017, Bandit and Deputy Lopez completed the course and we were certified and ready to go.

During his time on patrol, K-9 Bandit had multiple surrenders, building searches, persons searches and two apprehensions. K-9 Bandit was four for four when it came to persons searches, two ended in surrenders and two ended in the apprehension of dangerous felony suspects.

K-9 Bandit participated in several trials throughout California. Bandit's first trial at Stanislaus County was as a novice and he won first place. Bandit's last trial was at the Yuba City Police Departments trial by our office. Bandit trialed with the big dogs and won first place on area search, fourth place overall and fourth place protection, not bad for the new dog in town. When not on patrol, or participating in trials, Bandit enjoyed running the house with the Lopez's boys. Bandit enjoyed playing with the kids, hanging out with them and was the best partner/family member/friend anyone could ask for.

While assisting Butte County during the Campfire, K-9 Bandit was shot and killed attempting to apprehend a suspect wanted in connection to a double homicide.

Peace Officer of The Year 2017

John Lopez



Deputy Lopez graduated the Yuba College Police Academy on May 8th, 2008 and was hired on with the Sutter County Sheriff's Office on February 15, 2009. Deputy Lopez was assigned to patrol where he completed his field training program before becoming a solo patrol deputy. Deputy Lopez has served the Sutter County Sheriff's Office in the following capacities: Cadet Advisor, Ride-A-Long Coordinator, School Resource Officer (SRO), Boat Patrol Deputy, Operator on the Special Enforcement Detail team (SED), detective in NET-5 and as a K-9 handler with his K-9 partner Bandit.

Deputy Lopez received a life-saving award for his efforts in the successful outcome of an incident where a citizen nearly lost her life. Deputy Lopez also received an award from the California Highway Patrol for his efforts in recovering stolen vehicles. In February of 2018, Deputy Lopez received recognition as the Sutter County Sheriff's Office's Officer of the Year award. When not at work, Deputy Lopez enjoys spending time with his wife, Tabatha and their four boys, Christopher, Justin, Bryce and Kaleb.

Peace Officer of The Year 2018

Shawn Roberts



Shawn was a member of our armed forces and served in the Marines as part of the infantry division from 1988-1992. From there, law enforcement seemed like a natural transition from Shawn. He worked for a brief period as a correctional officer in the State of Illinois before moving to California. Shawn began working at the Yuba County Sheriff's Department in December of 1993. He had aspirations of becoming a patrol deputy and attended the police academy at Yuba College in 2000. Shawn eventually realized his dream when he accepted a job at the Sutter County Sheriff's Department in December of 2006. Since that time, Shawn has served the residents of Sutter County and he is currently assigned to our contracted City of Live Oak. In 2017, Shawn was one of several officers that responded to a vehicle accident, in which a vehicle had become submerged under water in an irrigation ditch. Shawn's quick response and subsequent actions resulted in occupants being successfully removed from the vehicle. There is no doubt, three lives were saved that day and Shawn was directly involved in this rescue operation. As a result, he received the department's Life Saving Award as well as recognition from the Offices of Senator Jim Neilson and Assemblyman James Gallagher. November 2018, Shawn helped coordinate a Turkey drive in the City of Live Oak. Shawn partnered with Jeff and April Helm, the owners of Fit Republic, and through their collaborative efforts provided dinners to 55 families in the Maple Park Homes. We have an internal practice for selecting our officer of the year and Shawn received the highest number of votes from his peers. He was also unanimously chosen by our command staff to represent the department.

2018 Retirements

Sheriff J. Paul Parker



Sheriff J. Paul Parker is a 46-year veteran of Law Enforcement. He started his career in law enforcement as one of the original Sutter County Sheriff's cadets in 1972. He then moved on to work as a Police Officer for the Live Oak Police Department in 1976. Sheriff Parker returned to the Sheriff's Department in 1980 as a patrol deputy and since that time he continued his career within the department, attaining the rank of Corporal in 1985, Patrol Sergeant in 1989 and completing several years as a Detective Sergeant. Sheriff Parker rose to the rank of Captain in 1999, commanding the Jail Division of the Sheriff's Department and the Patrol Division in January 2003. In July 2006 he was appointed to the position of Undersheriff by Sheriff Denney. In April 2008, he was appointed as Sheriff-Coroner of Sutter County after the retirement of Sheriff Denney and has subsequently been elected twice as the Sheriff of Sutter County.

During his career Sheriff Parker was twice voted as officer of the year by the Marysville Exchange Club and Officer of the year by the Sutter County Sheriff's Office. He has held positions on special details while an officer and deputy, such as cadet coordinator, reserve officer coordinator, traffic accident reconstruction officer, Field Training Officer, SWAT Team leader, and he was a court recognized fingerprint expert. He previously was an instructor for Yuba Community College at both the police and jail academies in courses dealing with jail security and domestic violence issues.

Sheriff Parker holds a Bachelor of Science degree and is a graduate of the FBI National Academy-class 195.

Sheriff Parker is a lifelong resident of the Yuba/Sutter area and lives in Yuba City with his wife Kate. Sheriff Parker has two daughters, (Jacqueline and Samantha) a son (Jacob) and six grandchildren.

Undersheriff Jeff Pierce



Undersheriff Jeff Pierce retired in 2019 after 38 years of dedicated service to Sutter County. Pierce began his career in 1981 and was promoted to canine shortly after being hired.

Pierce worked his way through the ranks holding various assignments over the years. Pierce served as a Field Training Officer, Narcotics Officer, and was promoted to the ranks of Sergeant and Captain. At the rank of Captain, Pierce served in the Operations Division, Support Services Division, and the Detective Division. He was well versed in all aspects of the organization.

Pierce was a member of the Sheriff's Tactical Team and served as an operator from 1989 through 1997. Pierce was then promoted to the position of Tactical Team Leader where he served until 1999 when he was again promoted to Tactical Commander. Pierce ran the tactical team and supervised all tactical operations through 2010.

In 2001 Pierce graduated for the F.B.I. National Academy, class 207

Pierce was promoted to the rank of Undersheriff in 2010 and held that position until his retirement. Pierce was directly involved in budget preparations as well as the overall management of the Sheriff's Office.



SUTTER COUNTY SHERIFF'S OFFICE BEATS



OPERATIONS DIVISION

Of the three divisions at the Sutter County Sheriff's Office, the Operations Division is the most visible to the public. There are many units and specialty assignments within the Operations Division with include:

The Sutter County Sheriff's Office issued 1,315 moving violation citations. These violations include primary collision factors such as excessive speed or stop sign violations as well as unlicensed drivers and other mechanical violations. In addition, the Sutter County Sheriff's Office responded to over 63,000 calls for service. These calls for service include suspicious persons/vehicles, thefts, medical aid, domestic violence, assaults, juvenile issues and mental health/crisis events.

The Sutter County Sheriff's Office was awarded two grants from the California Department of Public Health and California DOJ to enforce tobacco violations and provide education. The grant uses Proposition 56 funds to provide education to retail stores, juveniles, schools and enforcement for tobacco related violations.

Sheriff's Office Volunteers accumulated over 1,800 hours of service to the Sutter County communities. The Sheriff's Office Volunteers assist in special details, rural patrols, vacation checks and other errands which free up the deputies to focus on suppressing criminal activity.

Notable Cases

In March, Sutter County Deputies were dispatched to the area of Kirksville Road in regard to a subject shot in the head. Upon arrival, a Deputy located the lifeless victim, and immediately began administering CPR while controlling the scene. Through investigation, the shooting was determined to be accidental. The victim was transported by air to UC Davis medical center and ultimately survived his injuries.

In May, Sutter County Deputies were dispatched to a traffic accident on Highway 99, which involved multiple vehicles and patients with major injuries. Deputies contacted a female who was involved in the accident and was suffering for multiple injuries to include head trauma and major arterial bleeding from the arm. Both Deputies grabbed a medical kit and placed a tourniquet on the female and controlled the bleeding. The female was transported by air to UC Davis medical center and survived her injuries.

In July, Sutter County Deputies responded to a single vehicle accident in the area of Lincoln Road. The vehicle was submerged in an irrigation canal and the driver was trapped under water. A Deputy jumped into the water and began searching for the driver. He located the driver who had drifted downstream and was able to pull him out. Deputies performed CPR and the driver was transported to the hospital.

In July, Sutter County Deputies investigated a robbery that took place at a residence in Yuba City. The victim reported that the suspect assaulted him with a firearm and stole four hundred dollars out of his pockets. Deputies positively identified the suspect, who had a violent criminal history and was a convicted felon. Deputies authored a search warrant for the suspect's residence and seized two firearms, ammunition, a taser, and illegal narcotics. The suspect was taken into custody and was booked in the Sutter County Jail.

OPERATIONS DIVISION

In December, while on routine patrol a Deputy made an enforcement stop on a vehicle for a traffic violation. The driver was a documented member of the Sureno criminal street gang and had a warrant for his arrest for murder. He was also a convicted felon and was found to be in possession of a stolen firearm. Deputies authored a search warrant for the suspect's residence and seized eight firearms. The suspect was booked into the Sutter County Jail on numerous felony charges.

- In February, FBI requested the SED Team to serve a search warrant at Maple Park, in Live Oak. The warrant was for the seizure of firearms and gang indicia. SED team safely executed the warrant without incident and released the scene to FBI.
- In April, the SED team was called out to resolve a barricaded subject incident at Reagan Way. The suspect had assaulted a victim with a firearm in YCPD jurisdiction. Negotiations were not successful, and the team deployed chemical agents into the residence. During entry, the suspect was located and taken into custody. The residence was released to YCPD for investigation.
- In September, the SED team was called out to resolve a barricaded subject incident at Nicolaus Avenue. The subject was armed with a firearm and had fired a round inside the residence. During announcements, the suspect exited the residence and became combative with team members. He was taken into custody and the residence was released to the Detectives.

OPERATIONS DIVISION

Live Oak

In 2018, the Sutter County Sheriff's Office handled almost 16,000 calls for service. These calls for service include traffic accidents, trespassing, domestic violence, assaults, and suspicious persons to name a few. Over 1,100 incident reports (includes citations) were taken, 174 misdemeanor arrests and 70 felony arrests were made.

Notable Cases

Deputies investigated a rape case which alleged a juvenile had been raped by a 21 year old subject after the victim became intoxicated. The investigation included a search warrant into the suspects cellular phone and a full confession was obtained from the suspect. The suspect was later convicted.

Dep. Garcia discovered a suspicious vehicle in the area of the little league fields late in the evening. He found the vehicle occupied by a known gang member who was on probation. During a probation search he located of two handguns and additional weapons which were seized as evidence. During the arrest of the subject, numerous shots were heard in the area in what appeared to be an attempt to distract or intimidate the officers

While investigating a stolen motorcycle report, Deputy Roberts discovered the two suspects a block from where the theft occurred. Deputy Roberts wrote a search warrant into the residence and discovered the stolen motorcycle, narcotics, money, and firearms. This case led to other cases where additional firearms were seized by NET-5. Several suspects were convicted in this and follow-up cases.

Dep. Smith was dispatched to a domestic violence incident where the suspect was throwing rocks at the victim's residence and yelling profanities at her. As Dep. Smith was trying to remove the suspect from the property to speak with him, the suspect fought with Dep. Smith. During the incident the suspect attempted to grab several items out of Dep. Smith's gun belt. An unidentified subject came to Dep. Smith's aide and helped him place handcuffs on the suspect.

Deputies participated in the Live Oak Cleanup Day, National Night Out, Live Oak Parade & Festival, Trunk or Treat, and the Christmas Stroll.

Deputy Roberts coordinated the distribution of 55 turkey dinners for low-income and senior residents at Maple Park Housing.

OPERATIONS DIVISION

Notable Cases:

In January, Deputies were contacted by Sutter County Probation regarding an inappropriate relationship between a minor and her presumed father. The Probation Officer advised our deputies that the minor disclosed to her that her father had molested her when she was six (6) years old. Detectives took over and conducted an extensive investigation. During the course of that investigation it was determined that the suspect was not the victim's biological father and had been continually groping, molesting and annoying the victim. The suspect was arrested, prosecuted and inevitably found guilty of molestation and sexual battery.

In March, Deputies responded to a 911 call of shots fired and a man down. Deputies responded to a remote area of Kirksville Road and found an unconscious victim who had been shot in the head with a high-powered rifle. Detectives arrived, processed the scene and conducted interviews. They later determined the victim was shot by his friend in a gross negligent manner as they were drinking and target shooting. The suspect was arrested and charged with Discharging a Firearm in a Gross Negligent Manner.

In April, Deputies responded to a report of an unresponsive infant who may have ingested marijuana. The child was immediately transported to Rideout, then rushed to Anderson Luchetti Medical Center in Sacramento. Detectives responded to the hospital and interviewed the mother and doctor. Later, detectives interviewed the suspect (boyfriend) who admitted to smoking and haphazardly leaving his marijuana all over the floor and apartment. The suspect also admitted to thinking it was humorous to watch the infant, as she lay incoherent and unresponsive. The suspect was arrested and charged with Child Endangerment.

In May, Deputies responded to the 1400 area of Creswell Drive regarding an assault with a deadly weapon. When they arrived, deputies found the victim had been stabbed in the head/neck and shoulder area and was bleeding profusely. Detectives responded and took over the investigation. During the investigation, Detectives learned that the victim and suspect became embroiled in a verbal argument, which escalated. The victim said the argument escalated when the suspect slapped the victim. When confronted by the victim, the suspect pulled out a knife and slashed her about the face and neck causing deep and life-threatening wounds. Inevitably the injuries have left the victim scarred and permanently disfigured. The victim now limps, slurs her words and struggles to speak. The suspect was charged with Attempted Murder and possession of Methamphetamine.

In November, Detectives received further information on an unidentified decedent known as "John Doe." Detectives vigorously pursued these new leads that indicated the unidentified decedent was possibly the main suspect wanted in a brutal homicide out of Washington State. With the help of the Coroner's Office, the Department of Justice, the Washington State Police and Social Media, Detectives were ultimately able to match John Doe to the homicide suspect and bring closure to two unsolved cases.

SUPPORT SERVICES

The Sutter County Sheriff's Office Support Services Division is responsible for providing support to units and divisions within the Sheriff's Office through a wide variety of programs and services. The division is responsible for overseeing Communications, Records, Civil, and Concealed Weapons Permits. Support Services is a key part of the everyday functions ran by the Sutter County Sheriff's Office.

DIVISION HIGHLIGHTS

Communications / Dispatch

Our communications center is in operation 24-hours per day 7-days a week. The center is equipped with three dispatch consoles, receiving 911 calls, within Sutter County, as well as non-emergency and business calls. The center strives to answer all 911 calls on the first ring, and our answer time statistics with the State of California are among the fastest in the state. Each console is also equipped with over a dozen law enforcement and fire radio channels to communicate with emergency responders. The dispatch center is always staffed with a minimum of two dispatchers. The dispatchers are committed to quickly reviving, responding, and dispatching calls for service and are often the first point of contact with help is needed. We strive to meet the motto "Dispatchers save seconds, and seconds save lives."

The Sutter County Communications Unit is a Public Safety Answering Point (PSAP). Our Communications Center has the responsibility of answering incoming 911 calls as well as non-emergency calls for service. Our dispatchers answered a total of 146,543 calls in 2018.

Radio-dispatching services for the Sheriff's Office as well as the six (6) Sutter County Fire Departments are provided by the Communications Center. At times we also assist and communicate with Animal Control, Public Works, and sometimes Fish & Game field personnel. Our center is manned twenty-four (24) hours, seven (7) days a week, with a minimum of two dispatchers on duty at all times.

On July 1, 1999, the Sutter County Sheriff's Office began supplying EMD (Emergency Medical Dispatching) in which pre-arrival medical assistance and instructions are provided by the Dispatcher to the citizens of Sutter County.

Our dispatchers also process reports from the deputies, reportable death reports, hospice placement, restraining orders, warrants, and DOJ validations.

SUPPORT SERVICES

Records Division

The Records Unit of the Support Services Division is staffed with three Criminal Records Technicians.

The Records Technicians provide a wide range of functions including:

- Live Scan transmissions to the California Department of Justice
- Applicant fingerprinting
- Parade permits in County jurisdiction
- Solicitor permits in County jurisdiction
- Explosive permits
- Concealed weapons permits in Sutter County
- Maintenance of agency reports and records including court mandated functions
- Process record release requests
- Process criminal offender registration such as narcotics/sex/arson and gang registrants
- Compile monthly statistical reports for the Department of Justice Uniform Crime Reporting
- Provide information to citizens either by the public counter or by telephone
- Maintain and provide information regarding towed vehicles
- Maintain information regarding the Offender Watch program

Civil Division

The Civil Unit is part of the Support Services Division and is charged with the processing of civil process as prescribed by law. It is the goal of the Civil Unit to serve all received process in a reasonable and timely manner while maintaining an impartial stance between all parties involved or having an interest in a case. The civil process includes summons and complaints, small claims documents for a civil lawsuit, restraining orders, and any other notice or order from the courts. The civil unit is also charged with placing a levy on bank accounts, wages, vehicles, or any asset of the judgment debtor. All documents submitted must include a letter of instruction(s) to the Sheriff and a fee for the service (Per CCP 262).

SUPPORT SERVICES

BACKGROUNDS

- 30 Backgrounds were assigned to be investigated during this year.
- 5 Candidates either withdrew from the process or were disqualified from employment
- 15 employees have been hired from backgrounds during this quarter.

CONCEALED WEAPONS PERMISTS (CCW'S)

- 773 CCW renewals were signed and issued
- 276 CCW modifications were made to permits (delete or add firearms)
- 329 New CCW permits were issued
- 4 citizens are in the process of being denied CCW permits

TRAINING AND STANDARDS

- Administration, Patrol, Dispatch, and Detectives employees have attended over 2,600 hours of internal and outside training classes during this year.
- Correction Officers attended over 1,400 hours of STC Certified in house and outside training during this year.
- All working employees met either Standard and Training for Corrections (STC) or Peace Officer Standards of Training (POST) training standards.
- During this calendar year, over 18 employees attended a agency taught Supervisor Development Training Course which was geared to educate and prepare employees who aspire to promote.
- 3 employees were sent to training classes to be SCUBA certified.
- 3 employees were sent to SWAT Operator school.
- 2 employees were sent to Advanced Boating schools.
- Patrol Deputies and Correctional Officers attended and completed perishable skills training in several disciplines such as; Defensive Tactics, CPR, Excited delirium, Less Lethal Deployment, Jail Scenarios, Rifle and Handgun Training, Val Tox Drug Testing, Emergency Vehicle Operation and multiple other courses.
- Multiple supervisors and Management staff attended required state mandated trainings.

JAIL DIVISION

The Jail Division is responsible for the operation of our 355-bed facility. The primary mission of the Sutter County Jail is to ensure public safety by the secure detention of those persons committed to our custody, and to ensure that those persons committed to our custody are provided a safe and humane environment with treatment and educational programs consistent toward that end. Some of the programs include G.E.D., Life Skills, Anger Management, Morale Re却onition Therapy and Peer Relations. Programs for substance abuse and alcoholism are also offered.

In addition to housing the Sutter County inmates the jail also houses inmates for Beale Air Force Base while they are awaiting their court proceedings. On average the jail maintains 2 Beale inmates and have had as many as 6 military inmates. We also provide mutual aid to other facilities by housing inmates with special considerations and vice versa.

Daily, Jail staff are tasked with the processing of persons into and out of custody, providing custodial and security services for incarcerated and detained individuals for the Sutter County Sheriff's Office and other outside agencies. In doing so, the Jail is responsible for the health, safety, care and welfare of those individuals housed in the facility, as well as for the safety of those sworn and civilian employees who provide services within the Jail Division ensuring proper medical treatment and nutrition for the confined population, and providing access to exercise, clean clothing and laundry.

In addition to the Main Jail staff we have 6 Correctional Officers and a Sergeant assigned to the Sutter County Superior Court. The officers are responsible for the security of the court rooms and the safety of the judges and other court staff.

The Transportation Unit has daily responsibilities of getting inmates to outside medical appointments and transferring of inmates to and from other correctional facilities and court appearances.




