August 12, 2022	E-88	Last Day to Submit Resolutions of Consolidation	<p>Final deadline for the governing body of a district, city, school or other political subdivision which requests consolidation of a local election for candidates and/or measures to file the request with Sutter County Elections. Earlier filing dates are encouraged in order to meet printing schedule.</p> <p>Whenever resolutions calling for a measure to be placed on the ballot are filed, immediately after that filing date will be a 10-day public inspection period. Documents will be on public display at Sutter County Elections.</p> <p>During this period, any voter of the jurisdiction or the county elections official may seek a writ of mandate or an injunction requiring any or all of the materials to be amended or deleted.</p>	§§9190, 9380, 10401, 10402, 10403
August 19, 2022	E-81	Deadline to File Arguments, Analyses for Measures	<p>Arguments for or against any local measure called for the November 2022 elections are due by Close of Business.</p> <p>County Council to submit impartial analysis for county and school/special district measures.</p> <p>City Attorney to submit analysis of city measures.</p> <p>County Auditor, if previously directed by the Board of Supervisors, to submit fiscal analysis of measures.</p> <p>Arguments and analyses are public record after the Close of Business deadline. August 20, 2022	E-80	10-day Public Inspection for Arguments and Analyses Begins	<p>During the 10-calendar-day public examination period provided by this section, any voter of the jurisdiction in which the election is being held, or the county elections official, himself or herself, may seek a writ of mandate or an injunction requiring any or all of the materials to be amended or deleted. The writ of mandate or injunction request shall be filed no later than the end of the 10-calendar-day public examination period.</p>	§9190
