Generation Next ACADEMY SPONSORSHIP PROGRAM

The Sutter County Sheriff's Office is continuing to implement a new recruiting tool by sponsoring Deputy Sheriff Trainees at the Butte Police Academy. We are continuing to create an opportunity for those vested in our community who need some assistance in furthering their careers. This position is one that the Sutter County Sheriff's Office sponsors for those who have successfully passed an oral panel, Pellet B Test, Physical agility test, an extensive background, and medical screening. Since 2020 we have sent 14, which include the 6 that are photographed below. All 14 have successfully passed the police academy. The six photographed below are Deputy Tapia, Deputy Howard, Deputy Moreno, Deputy Moseley, Deputy Tarke, and Deputy Cueva. They were extremely successful in the academy winning scholarships, top report writing, assigned as a academy sergeant and lieutenant. They all represented Sutter County Sheriff's Office with honor and respect. Sheriff Barnes was extremely proud of all of them.

Core ACADEMY

Correctional Officers are enrolled in the academy for five weeks with members of agencies from around the northern state. Throughout the academy officers are trained and educated on the principles of working in a correctional facility. Officers are trained on use of force, defensive tactics, hand cuffing, and cell extraction. Officers are required to complete an STC (Standard and Training for Corrections) Certified Correctional Academy within one year of employment. The academy, paired with on-the-job training, prepares officers for what to do and provide expectations for working in a correctional facility.

In addition C/O Major took home the top gun award for the best overall shooting of the weekend, and C/O Wells won the steel distance challenge.



Staffing CHALLENGES

In 2022, the Sheriff's Office experienced staffing challenges in some key areas of the organization. This was due in part to several classifications of employees earning less money than at some neighboring public safety departments. The Sutter County Board of Supervisors approved equity adjustments for employees, which allowed the Sheriff's Office to be competitive in the job market. This was helpful with recruitment and retention and even allowed the Sheriff's Office to hire several lateral employees, which means they are experienced personnel choosing to work here in Sutter County.

At one point during the year, our communications center was so short staffed we had to seek assistance from a neighboring agency to provide dispatch services during nighttime hours. This allowed the Sheriff's Office to focus on hiring and training of essential staff in our communications center. We are proud to say that despite our staffing challenges, there were no reductions in services.

We believe Sutter County is a great place to work. Our supervisors and line staff have created a professional, proactive, and fun environment that attracts applicants who are looking to be part of something special.

The result of search warrants served in Live Oak and South County. SCSO deputies investigated crimes that lead to information regarding the felon's in possession of firearms. On top of the two warrants, SCSO deputies have been busy being proactive in the county, which includes an arrest for methamphetamine and suspected fentanyl in the area of Willow Street, Nicolaus, detectives located stolen property which included a UTV, ATV, and firearms in a campsite near Shanghai Bend, numerous DUI arrests, and a felon in possession of ammunition in the area of Anna Drive, Yuba City.



Sutter County Sheriff's Office was dispatched to the area of Natomas Road and Field Road, Pleasant Grove, regarding possible shots fired. Deputies arrived on scene and contacted numerous subjects in the 6000 block of Natomas Road. One of the Deputies observed a barrel to what appeared to be an AR-15 rifle. This led to an investigation of the incident. Deputies located other firearms near the six subjects and spent casings. It was determined that two of the six subjects were felons and were not supposed to be in possession of firearms. K-9 handler Deputy Pope utilizes his K-9 partner "Jari," to conduct a further search of the area and located another handgun.

On May 24, 2022 a search and seizure warrant were executed on the basis of suspected animal cruelty and neglect in Pleasant Grove.

The Sutter Animal Services Authority, Sutter County Sheriff's Office and Sutter County Code Enforcement combined their efforts to seize 63 animals which included: 39 dogs, 13 horses, 7 cats and 4 exotic birds.



The warrant served was due to a collaborating effort between Animal Control Officers Newman and Terry with the Sutter Animal Services Authority and Deputy Arbaugh with the Sutter County Sheriff's Office. After the warrant was served, Pleasant Grove residents, 50-year-old Lynette Kim Countryman-Dunivan and 51-year-old Chad Damon Dunivan, were arrested for numerous felony charges, including animal abuse.

Peace Officer Memorial



On May 15, 2022 at approximately 2216 hours, Sutter County Sheriff's Office Deputy Harrison attempted to conduct a traffic stop on two vehicles that were racing in the area of Highway 99 and Highway 20 in Yuba City. The two vehicles were traveling at approximately 100 MPH southbound on Highway 99. The Corvette fled from Deputy Harrison at approximately 100 MPH northbound Highway 99. When the Corvette reached Highway 99 and Lomo Crossing it turned around on Highway 99 and fled southbound on Highway 99 at approximately 140 MPH. Deputy Harrison noticed the Corvette had turned its lights off and was driving in the wrong lane against traffic at a high rate of speed. Due to the Corvette driving with wanton disregard for the public, the vehicle pursuit was terminated.

CASE OF THE MONTH

On 8/26/2022 in the morning hours, Sutter County Deputies were dispatched to 6000 block Garden Hwy in Yuba City for a report of an assault with deadly weapon. After deputies arrived on scene, they noticed an RV fully engulfed in flames threatening multiple structures. Deputy Shorey immediately entered a shed that was located feet from a burning RV and located the victims of the incident and were able to pull them to safety. Deputy Shorey observed the victim was bleeding heavily from his head and had medical personnel respond to assess the victims' injuries. Deputies on scene were able to relay a sufficient description of the suspect who had fled in an unknown direction.



At about 1014 hours, Deputy Gutierrez and Reserve Deputy Corey were patrolling the Feather River in a Sheriff's Office Boat when they located the suspect sitting on the bank of the river. Boat patrol deputies quickly apprehended the suspect and transported him to Boyd's Pump boat launch and ultimately to the Sutter County Jail and was charged with 148(a)(1) PC, 212.5(a) PC, 245(a)(1) PC, 422(a) PC, and 591.5 PC.

National Night Out



CASE OF THE MONTH

On 9/4/2022, Deputy Evans conducted a traffic stop in the area of Franklin Road/ North Walton Avenue on a 2001 Black Toyota Tacoma. While on the traffic stop, Deputy Evans saw pepper spray in the vehicle and had dispatch run a check on the driver for felony convictions which revealed he was a felon. Deputy Evans removed the driver from the vehicle and subsequently searched the vehicle. While searching the vehicle, Deputy Evans located what she believed to be five pipe bombs, a black powder handgun, and components to make destructive devices. Based on Deputy Taylor's observations, the area surrounding the vehicle stop was evacuated and all traffic was rerouted, and the Butte County Interagency Explosive Ordnance Team was requested and later responded.



After further investigation from the Butte County Explosive Ordnance Team, one destructive device was rendered safe, 12 destructive devices were seized, 8 Zip guns were located along with a personal amount of methamphetamine and a methamphetamine smoking pipe. Butte County Bomb Squad seized the 12 destructive devices and 8 Zip guns. The driver was arrested and booked into the Sutter County Jail for Felon in possession of tear gas, felon in possession of a firearm, felon in possession of ammunition, 13 counts of possession of a destructive device, 8 counts of a Zip gun, 1 count of possession of material with intent.

On 9/7/2022, Deputy Evans authored a Search warrant for the home of the suspect which was in the 5000 block of Chestnut Road in Olivehurst, California. On 9/9/2022, the search warrant was executed through multi-agency cooperation that was comprised of Sutter County Sheriff's Office deputies and detectives, Butte County Interagency Explosive Ordnance Team, Federal Bureau of Investigations and Federal Bureau of Alcohol Tobacco and Firearms. The search of the said residence revealed more illegal destructive devices and components to manufacture additional destructive devices.

On October 23, 2022, Deputy Mathews was dispatched to Adventist-Rideout Hospital in reference to a possible sexual assault of a 20-year-old woman. Deputy Mathews immediately took measures to make the victim feel safe, conducted an interview and established a crime had occurred.

Deputy Mathews conducted several interviews and ultimately authored a search warrant which resulted in the arrest of the suspect who was later booked into the Sutter County Jail for multiple violations of felony sexual assault related charges.

CASE OF THE MONTH

Sutter County Dispatch received a phone call from a male informing his vehicle had been stolen and he was currently in an orchard located on Hutchinson Road. Once deputies arrived on scene, they noted the "victim's" legs were bound with a zip tie. There was also a zip tie around his neck.

The male subject was discovered to have charred clothing and claimed to have been robbed at gunpoint/knife point by two subjects who then stole \$1,000 in cash and his pickup. He said prior to the suspects fleeing the scene, they doused him in gasoline and lit him on fire.

Detective Aguilar interviewed the male who provided a full statement and description of involved suspects. Detectives began working the case, attempting to identify the suspects.

Detective Aguilar authored and executed numerous search warrants for cellphone records. It was ultimately proven the male had fabricated the story for unknown reasons and was arrested for filing a false police report.

US Marshals AWARD



Detail (SED Team) and the Crisis Negotiation Team (CNT) were presented an honorary award in appreciation for their dedication and assistance to the United States Marshals Service on May 12, 2022, in the apprehension of a violent foreign fugitive in the town of Sutter.

Life Saving AWARD

At approximately 2100 hours Dispatch received a call of a suicidal subject floating down the Sacramento River; the water temperature was 46 and the subject was hypothermic. Deputy Pope and Deputy Kopack responded with Knights Landing Fire Department and were able to get a rope to the subject who was now hanging onto a tree. Due to the steep bank of the river Deputy Pope was unable to get the subject out of the river. Sgt. Berg responded with a patrol boat from the Sheriff's Office where he met Deputy Kohler at the Knights Landing Boat Launch. Sgt. Berg and Deputy Kohler traveled up river approximately 3 miles and assisted medical personnel and Deputy Pope in getting the hypothermic



subject into the patrol boat. He was then transported to Knights Landing Boat ramp by boat for medical treatments.
